#### Who is this qualification for?

This qualification is aimed at those who work as surveyors working with glass supporting systems, including conservatories and other external glazed structures, and advanced walling systems etc.

This qualification is at Level 3 and should be taken by those who are experienced surveyors, capable of dealing with a wide range of problems, including working with installations that have complex requirements. Candidates will often take a technical supervisory role, particularly in relation to less-experienced surveyors.

Further GQA qualification at level 2 & 3, covering Fenestration Installation and Curtain wall installation are available.

Candidates for this qualification will primarily be working on and could be assessed in the context of surveying activities linked to Window and Doors or conservatories, or Curtain Walling.

#### Entry requirements

There are no formal entry requirements for learners undertaking this qualification. However, centres must ensure that learners have the potential and opportunity to gain the qualification successfully.
